At 7:00 p.m. Angela Cooper called the meeting to order and welcomed everyone in attendance. It was announced that the meeting was being held with the Startmeeting.com platform because of COVID-19 and the current heath concerns for Secretary/Treasurer Nina Garretson.

**Old/New Business:** Discussion regarding RKL (formerly Rotz & Stonesifer) Certified Public Accountants, who have been contracted by Hamiltonban Township, to conduct the 2021 audit of all financial accounts. Board of Supervisors approved by resolution on January 3, 2022.

Discussion concerning the increased amounts for skilled and unskilled supervisors pay. Secretary Garretson suggested to consider the pay rate to current Township employees. Carol Leaman motioned that Skilled Supervisor rate be increased to \$18.00, Unskilled Supervisor be increased to \$16.00. Chairperson Cooper seconded. The motion carried unanimously.

Brief discussion of Township accounts began. Chairperson Cooper was particularly interested in the Advertising account being over budget, the Highway Construction & Rebuild account over budget and the Employee Health/Hospitalization being under budget.

Discussion of the ARPA Fund. Supervisor Deardorff explained that the ARPA Fund can only be used in certain areas. Secretary Garretson said that a separate CPA firm, Zelenkofsky

and Axelrod has been contracted to research any possible areas for the funds use and compliance.
