# Minutes of Tuesday, March 12, 2019

#### **Regular Meeting**

Call to Order by Chairman Terry Scripture at 7:03 pm

<u>Approval of minutes from January 15, 2018</u>: 1<sup>st</sup> motion by Matt Inskip; 2nd by John Strahler. Motion approved.

Treasurer's Report: Fund Balance as of \$16,474.21 as of 2/28/2019

#### **Old/New Business:**

<u>Robert G. Olyphant:</u> Robert has agreed to join the commission and the members are excited to have a complete commission. The commission is asking that the Board of Supervisors approve Mr. Olyphant at their next workshop. Terry will email Nina and ask her to put it on their agenda.

<u>Grants Updates</u>: Green space grant to be turned in March 13, 2019 we are expecting a surplus of \$2,392.04. Coleen is also to work on the Tree grant. There is also the Adams County Community Foundation Grant. Coleen reported that there is \$8,138 left to use.

**Boy Scouts:** The Boy Scouts have not shown much interest in doing an Eagle Scout Project for the park. However, some Scouts may be able to help with Kite Day.

<u>By-Laws Discussion:</u> The commission proposed the changes be made to the noted documents was voted on by the commission and will be sent to Board of Supervisors for approval. First motion by Terry Scripture, Second by Matt Inskip. Approved Unanimously. Terry will email Nina and ask her to put it on the agenda for the BOS workshop.

<u>Kite Day</u>: Kite Day is to be April 13, 2019 in the morning time TBD. We are blessed to have Mr. Whitmore a professional kite flyer from Carroll Valley to assist with this event. A request is going to be made to the Board of Supervisors to expend \$200 from the Parks and Rec Township budget to help pay for supplies. The Boy Scouts may help with this event as mentioned earlier. Coleen to call Mr. Whitmore and work out details. Flyers and other ways to promote the event will be worked out via a group e-mail. Terry will email Nina and ask her to put it on the BOS workshop agenda.

<u>Meadow Plugs</u>: The cost of the meadow plugs is to be \$3372.54 and there was discussion about the easiest way to plant the plugs. Discussion and investigation to be continued.

<u>Bridge</u>: There was discussion about the second bridge to be built. The commission is still investigating the best way to construct the bridge. John Strahler has been investigating an alternative way to build a functional bridge that would be affordable.

<u>Planning Workshop</u>: John Strahler has suggested a workshop to set specific goals and some more formal planning for the park. To be continued.
