At 7:00 PM Supervisor Gordon called the meeting to order and welcomed the public. The Pledge of Allegiance was recited. He announced that Hamiltonban Township is a Township of the Second Class and by State regulation must reorganize tonight. The meeting is being recorded for the sole purpose as a review aid in compiling the written minutes.

Supervisor Woerner motioned to appoint Robert L. Gordon as temporary Chairman and Nina Garretson as temporary Secretary. Supervisor Deardorff seconded. The motion carried unanimously.

Supervisor Dille motioned to appoint J. Edward Deardorff as Chairman of the Hamiltonban Township's Board of Supervisors. Supervisor Woerner seconded. The motion carried unanimously.

Supervisor Woerner motioned to reappoint Nina Garretson as Secretary/Treasurer with a treasurer's bond of \$500,000. Supervisor Dille seconded. The motion carried unanimously.

Supervisor Dille motioned to appoint Doug Woerner as Vice-chairman of the Hamiltonban Township's Board of Supervisors. Supervisor Deardorff seconded. The motion carried unanimously.

Vice-chairman Woerner motioned to reappoint J. Edward Deardorff as Road Coordinator. Supervisor Dille seconded. The motion carried unanimously.

Vice-chairman Woerner motioned to reappoint LuAnn M. Dille as Office Coordinator. Supervisor Dille seconded. The motion carried unanimously.

Supervisor Deardorff seconded. The motion carried unanimously.

Supervisor Deardorff motioned to adopt Resolution 2018-02: Review and Report Fees for Subdivision and Land Development. Vice-Chairman Woerner seconded. The motion carried unanimously.

Supervisor Deardorff motioned to adopt Resolution 2018-03: Hamiltonban Township Fee Schedule for 2018. Vice-chairman Woerner seconded. The motion carried unanimously. Solicitor Battersby requested that the fee schedule be posted on the website at another location other than Resolutions.

Vice-chairman Woerner motioned to adopt Resolution 2018-04: Appointing members to the Zoning Hearing Board. Supervisor Deardorff seconded. The motion carried unanimously. The members are Cynthia McNulty as alternate, John Luntz, Jim Izer, and to reappoint Gene Wiehagen to the Zoning Hearing Board (3 year term). Supervisor Deardorff seconded. The motion carried unanimously.

Supervisor Deardorff motioned to reappoint Dale J. Premo as the Vacancy Board Chairman (one year term); Vickie Gourley on the Municipal Authority Board (five year term) and we currently have another vacancy; Teresa Scripture and Dean Thomas on the Joint Parks & Recreation Commission (five year term); John Iaea and Gene Starbuck on the Planning Commission (four year terms); Joshua Donaldson to the Ag Security Council (seven year term). Vice-chairman Woerner seconded. The motion carried unanimously.

Supervisor Dille motioned to appoint as Delegate Robert Gordon as Delegate to the Adams County Council of Governments. Supervisor Deardorff seconded. The motion carried unanimously.

Supervisor Deardorff motioned to reappoint LuAnn Dille as Delegate and appoint Robert Gordon as Alternate Delegate to the Adams County Tax Collection Committee and York/Adams Tax Bureau. Vice-chairman Woerner seconded. The motion carried unanimously.

Supervisor Deardorff motioned to reappoint Coleen Reamer as the Delegate to the Adams County Bicycle and Pedestrian Plan Committee. Vice-chairman Woerner seconded. The motion carried unanimously.

Vice-chairman Woerner motioned to appoint Robert Gordon as the Delegate to the Joint Parks & Recreation Commission. Supervisor Dille seconded. The motion carried unanimously.

Vice-chairman Woerner motioned to retain ACNB Adams County Bank, Pennsylvania Local Governments Investment Trust (PLGIT), and F & M Trust as the Township's depository banks. Supervisor Dille seconded. The motion carried unanimously.

Vice-Chairman Woerner motioned to have the Township follow the Federal mileage allowance which is \$0.545 for 2018. Supervisor Martin seconded. The motion carried unanimously.

At 7:21 PM Vice-chairman Woerner motioned to adjourn the Reorganization meeting. Supervisor Martin seconded. The motion carried unanimously.

Board Meeting: At 7:22 PM Chairman Deardorff called the January Board of Supervisors meeting to order.

Approval of the Agenda: The Board unanimously approved the Agenda.

Approval of the Minutes: Vice-Chairman Woerner motioned to approve the December 5, 2017 Casino Hearing and Board of Supervisors Meeting Minutes; December 28, 2017 Special Meeting with Franklin Township and the December 28, 2017 Board of Supervisors Workshop Meeting Minutes. Supervisor Dille seconded. The motion carried.

Solicitor's Report: Solicitor Battersby presented his formal report at the meeting. He stated he has instructed Land and Sea Services to issue citations of violation of the Septic Pumping and Inspection Ordinance for four (4) land owners in Districts 1 and 2. He has also provided District Magistrate Beauchant with copies of our Ordinance. The Solicitor has been in contact with Franklin Township Solicitor Yannetti regarding agreement for the Hickory Bridge Road Bridge Project. He noted their was one (1) tax sale property in Hamiltonban Township which was on Iron Springs Road.

Discussion proceeded on code violations and complaints from property owners regarding junk. Secretary Garretson was instructed to notify Code Enforcement Officer to issue citations for two complaints received, on Mountain Lane and Bullfrog Road. The Solicitor explained that the citations are fines that must be paid. Chairman Deardorff said that if enforcement is not done neighboring land owners may file suit against the Township.

Vice-Chairman Woerner motioned to accept the Solicitors Report. Supervisor Martin seconded. The motion carried. Solicitor Battersby left the meeting at 7:29 PM.

Vice-chairman Woerner motioned to approve transfer from Capital Reserve Fund \$65,000 for the Mack truck upfit per the 2018 Budget. Supervisor Dille seconded. The motion carried unanimously.

Secretary's Report: Secretary/Treasurer Garretson submitted her formal report prior to the meeting. Vice-Chairman Woerner motioned to accept the Secretary's Report. Supervisor Dille seconded. The motion carried unanimously.

New Business: Vice-chairman Woerner motioned to approve Supervisor Gordon, Supervisor Martin, and Roadmaster Herr to attend the Annual PSATS Educational Conference and Trade Show, April 22-25, 2018. Supervisor Dille seconded. The motion carried unanimously.

Vice-Chairman Woerner motioned to accept the resignation of Deputy EMA Coordinator, Sarah Ginn and to send letter thanks for her service. Supervisor Gordon seconded. The motion carried unanimously.
